

ORDINANCE NO. 27-26

AN ORDINANCE TO AMEND ORDINANCE NO. 110-14 ESTABLISHING COMPENSATION FOR THE PART-TIME, UNCLASSIFIED POSITION OF PROJECT MANAGER FOR THE CITY OF AVON AND DECLARING AN EMERGENCY

WHEREAS, Council established the full-time, unclassified position of Project Manager pursuant to Ordinance No. 109-14 which passed on September 8, 2014; and

WHEREAS, Council established a pay range for said position with Ordinance No. 110-14 which passed on September 8, 2014; and

WHEREAS, the Administration, in an effort to be more competitive in attracting and retaining employees, recommends that the pay range be amended and set to an hourly rate of between Forty-Five Dollars (\$45.00) and Fifty-Five Dollars (\$55.00) per hour, together with all other benefits of a permanent part-time unclassified, non-bargaining unit employee commencing with the date of hire; and

WHEREAS, Council, upon recommendation of the Administration, finds adoption of the compensation being proposed for the permanent part-time, unclassified position of Project Manager to be reasonable and in the best interests of the health, safety, and welfare of the citizens of Avon in maintaining well-qualified, efficient, and productive staff for the City.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, LORAIN COUNTY, OHIO:

Section 1 – That Section 1 of Ordinance No. 110-14 which currently reads as follows:

Section 1 - That effective with the date of hire following passage of this Ordinance, the permanent, part-time, unclassified position of Project Manager shall be paid an hourly rate between Twenty-Six Dollars and Thirty-Two Dollars (\$26.00 - \$32.00) per hour as set by the Mayor. In addition, said employee shall receive all other benefits of a permanent, part-time, unclassified, non-bargaining unit employee.

shall be amended to read as follows: (New language in bold print; deleted text stricken)

Section 1 - That effective with the date of hire following passage of this Ordinance, the permanent, part-time, unclassified position of Project Manager shall be paid an hourly rate between **Forty-Five Dollars (\$45.00) and Fifty-Five Dollars (\$55.00)** per hour as set by the Mayor. In addition, said employee shall receive all other benefits of a permanent, part-time, unclassified, non-bargaining unit employee.

Section 2 - That the Finance Director is hereby authorized to appropriate funds necessary to meet the compensation established for this position as set forth in Section 1, above.

Ordinance No. 27-26 (Con't.)

Section 3 - That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4 - That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety, and welfare of the citizens of the City of Avon, the immediate emergency being the necessity to amend the pay range for the permanent part-time, unclassified position of Project Manager thereby enabling the Mayor to fill the position in time for said employee to begin oversight of major capital improvement projects soon to begin in the City of Avon ; therefore, this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.
