

ORDINANCE NO. 10-17

**AN ORDINANCE TO ESTABLISH COMPENSATION FOR THE TEMPORARY,
PART-TIME AND UNCLASSIFIED POSITION OF TEMPORARY
STUDENT INTERN FOR THE CITY OF AVON
AND DECLARING AN EMERGENCY**

WHEREAS, pursuant to Ordinance No. 9-17, Council established the temporary part-time, unclassified position of “Temporary Student Intern”; and

WHEREAS, Council must establish compensation for said position; and

WHEREAS, the Administration recommends that the starting pay for this position be established as a set sum over and above the State’s Minimum Wage (currently at \$8.15) based upon an individual’s years of experience; and

WHEREAS, Council, upon recommendation of the Administration, finds adoption of the compensation being proposed for the temporary part-time, unclassified position of “Temporary Student Intern” to be reasonable and in the best interests of the health safety and welfare of the citizens of Avon in maintaining well-qualified, efficient and productive staff for the City.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, LORAIN COUNTY, OHIO:

Section 1 - That effective with the passage of this Ordinance, the temporary part-time, unclassified position of “Temporary Student Intern” in their first year of hire shall be paid an hourly rate equal to the then current State of Ohio minimum wage plus one dollar (\$1.00). Temporary Student Intern in their second year of hire shall be paid an hourly rate equal to the then current State of Ohio minimum wage plus one dollar and fifty cents (\$1.50). A Temporary Student Intern in their third year or above shall be paid an hourly rate equal to the then current State of Ohio minimum wage plus two dollars (\$2.00).

Section 2 - That the Finance Director is hereby authorized to appropriate funds necessary to meet the compensation established for this position as set forth in Section 1, above.

Section 3 - That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4 - That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity of establishing compensation for the temporary part-time, unclassified position of “Temporary Student Intern” in order to maintain a well-qualified, efficient and productive labor force; therefore, this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.
