

ORDINANCE NO. 111-19

**AN ORDINANCE TO AMEND SECTION 1210.02 OF THE
CODIFIED ORDINANCES OF THE CITY OF AVON
CONCERNING COMPENSATION FOR
MEMBERS OF THE PLANNING COMMISSION
AND DECLARING AN EMERGENCY**

WHEREAS, the Administration has recommended compensation adjustments for members of the Avon Planning Commission; and

WHEREAS, Council, upon recommendation of the Administration, and taking into consideration the duties and responsibilities of the members of the Planning Commission, deems it to be in the best interests of the health, safety and welfare of the community to amend §1210.02 to allow for annual adjustments in compensation to members of the Commission.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, LORAIN COUNTY, OHIO:

Section 1 - That Section 1210.02 of the Codified Ordinances of the City of Avon which presently reads as follows:

1210.02 COMPENSATION

- (a) Commencing with the first pay period of 2009, the annual salaries of the members of the Planning Commission shall be three thousand, nine hundred (\$3,900.00) dollars.
- (b) Commencing with the first pay period of 2009, the annual salary of the Chairperson of the Planning Commission shall be one and one-half times the compensation paid to other members of the Planning Commission as set forth in subsection (a), above. (Ord. 39-99. Passed 3-22-99; Ord. No. 41-09. Passed 4-13-09.)

Shall be amended to read as follows: (New Language in Bold Print)

1210.02 COMPENSATION

- (a) Commencing with the year **2020**, ~~the annual salaries each~~ of the members of the Planning Commission shall **receive annual compensation in an amount to be established by City Council in its annual "Ordinance Establishing Compensation for Full and Part-time Administrative Positions Not Covered by Any Collective Bargaining Agreement,"** ~~shall be three thousand, nine hundred (\$3,900.00) dollars~~ **payable on a monthly basis.**

- (b) Commencing with the first pay period of **2020**, the annual salary of the Chairperson of the Planning Commission shall be one and one-half times the compensation paid to other members of the Planning Commission as set forth in subsection (a), above **and payable on a monthly basis**. (Ord. 39-99. Passed 3-22-99; Ord. No. 41-09. Passed 4-13-09.)

Section 2 - The Codifier is hereby instructed to insert all amendments to '1210.02 contained in this legislation. All other language contained in '1210.02 not specifically amended herein shall remain in full force and effect.

Section 3 - That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4 - That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity to amend Section 1210.02 of the Codified Ordinances to increase pay to members of the Avon Planning Commission; therefore, this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.
