

**ORDINANCE NO. 113-19**

**AN ORDINANCE TO AMEND SECTION 274.03 OF THE CODIFIED ORDINANCES  
OF THE CITY OF AVON CONCERNING COMPENSATION FOR  
MEMBERS OF THE CIVIL SERVICE COMMISSION  
AND DECLARING AN EMERGENCY**

**WHEREAS**, the Administration has recommended review of ACO §274.03 dealing with meetings and compensation for members of the Avon Civil Service Commission; and

**WHEREAS**, Council, upon the recommendation of the Administration, and taking into consideration the duties and responsibilities of the members of the Commission, deems to be in the best interests of the health, safety and welfare of the community to amend §274.03 to allow for annual adjustments in the compensation of members of the Avon Civil Service Commission.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, LORAIN COUNTY, OHIO:**

Section 1 - That Sections 274.03(a) and (b) of the Codified Ordinances of the City of Avon which presently reads as follows

274.03            **COMPENSATION AND MEETINGS.**

- (a)     Commencing with the year 2009, each of the members of the Civil Service Commission shall receive annual compensation in the amount of One Thousand, Forty Dollars (\$1,040.00) payable on a quarterly basis.
- (b)     The Chairperson of the Civil Service Commission shall be compensated at one and one-half times the compensation paid to other members of the Civil Service Commission, payable on a quarterly basis.

**Shall be amended to read as follows:** (New Language in Bold Print)

274.03            **COMPENSATION AND MEETINGS.**

- (a)     Commencing with the year **2020**, each of the members of the Civil Service Commission shall receive annual compensation in **an the amount to be established by City Council in its annual “Ordinance Establishing Compensation for Full and Part-time Administrative Positions Not Covered by Any Collective Bargaining Agreement”**, ~~of One Thousand, Forty Dollars (\$1,040.00)~~ payable on a **monthly** ~~quarterly~~ basis.
- (b)     The Chairperson of the Civil Service Commission shall be compensated at one and one-half times the compensation paid to other members of the Civil Service Commission, payable on a **monthly** ~~quarterly~~ basis.

Section 2 - The Codifier is hereby instructed to insert all amendments to '274.03(a)

contained in this legislation. All other language contained in '274.03 not specifically amended herein shall remain in full force and effect.

Section 3 - That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4 - That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity to amend Section 274.03(a) of the Codified Ordinances to allow for annual pay adjustments for members of the Avon Civil Service Commission; therefore, this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.
