

ORDINANCE NO. 18-23

**AN ORDINANCE ESTABLISHING A RANGE OF COMPENSATION
FOR THE PERMANENT, PART-TIME POSITION
OF CITY PROSECUTOR
AND DECLARING AN EMERGENCY**

WHEREAS, pursuant to Ordinance No. 133-22, which passed on December 12, 2022, Council increased the 2023 annual salary for the permanent, part-time, unclassified position of City Prosecutor to Fifty-Six Thousand, Seven Hundred, Eighty-Six and 08/100 Dollars (\$56,786.08); and

WHEREAS, the Administration, having reviewed the current salary, now recommends establishing a range of compensation for this position of between Fifty Thousand and 00/100 Dollars (\$50,000.00) and Sixty-Five Thousand and 00/100 Dollars (\$65,000.00), together with all other benefits of a permanent part-time, unclassified, non-bargaining unit employee of the City; and

WHEREAS, Council, in agreement with the recommendation of the Administration, finds adoption of the compensation range being proposed for the position of City Prosecutor to be reasonable and in the best interests of the health safety and welfare of the citizens of Avon in maintaining experienced, well-qualified, efficient and productive legal counsel.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, LORAIN COUNTY, OHIO:

Section 1 – That effective with the passage of this Ordinance, the range of compensation for the permanent, part-time, unclassified position of City Prosecutor shall be set as an annual salary of between Fifty Thousand and 00/00 Dollars (\$50,000.00) to Sixty-Five Thousand and 00/100 Dollars (\$65,000.00) together with any other benefits of a salaried, permanent, part-time, unclassified employee of the City and as directed by City Council. The compensation established in Ord. No. 133-22 for 2023 remains unchanged.

Section 2 - That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 5 - That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity of establishing a salary range of compensation for the permanent part-time, unclassified position of City Prosecutor; therefore, this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.
